| 7.   | Proposed Fire & Rescue Precept and Budget 2020/21                                      | <p>RESOLVED that:</p> <p>a) The Panel supports the Northamptonshire Police, Fire &amp; Crime Commissioner’s proposed Fire &amp; Rescue precept for 2020/21 if 1.99% remains the maximum increase permitted without the need for a local referendum.</p> <p>b) The Panel recommends that the Northamptonshire Police, Fire &amp; Crime Commissioner increases the Fire &amp; Rescue precept for 2020/21 by up to £5.00 at Band D if additional flexibility regarding the threshold for a local referendum is given in the final local government finance settlement.</p> <p>c) The Panel agrees to delegate authority to the Panel Chair and Deputy Chair to approve the final version of its report on the proposed Fire &amp; Rescue precept for 2020/21 to be submitted to the Police, Fire &amp; Crime Commissioner.</p> |
